APPLICATION	Make all your media rewritable! You can laminate it on top of any printed media to write with a washable marker/pen, to write and wipe out multiple times. The film is suitable also as anti-graffiti for One Way Vision film and to be laminated on the back side of magnets applied on vehicles, in order to protect the paint during warm seasons. Duration and efficiency: for indoor application you can write and wipe within 5 years, outdoor applications within 1 year. In order to avoid any stain, it is recommended removing the writing at least once a month.
STORAGE	12 months under ordinary condition at the temperature mean of 22 °C (minimum 15 °C, maximum 40 °C) and relative humidity of 50-55%.
